Assist in delivery and maintenance of human services course-work including coordination of curricula and off-campus fieldwork sites. Develop and prepare course and assessment materials, including online instruction. Assist with student recruitment and participate in college service, professional development, and student advisement activities.

**Qualifications:** Master’s degree in Social Work (MSW) required with a minimum of three years post MSW experience in social work practice, or other applicable/equivalent professional work. Candidate must demonstrate depth in discipline as evidenced by academic preparation and prior college teaching experience, preferably at the community college level. Familiarity with substance abuse issues considered a plus. Additional background in social work, human services, psychology, or criminal justice a plus. Commitment to student-centered, outcomes-based education with experience incorporating multiple instructional strategies and the use of technology in teaching and learning. Excellent written and interpersonal skills required. Experience in a variety of professional settings preferred. LICSW preferred.
